GSS 14/15: 9

It is my recommendation that the senate adopt a motion to establish a more effective procedure for the election of the GSS executive committee in the Spring semester of 2015. Given that a more substantive and permanent change would require an emendation of the Constitution there are certain parameters that must be followed for the election procedure this year:

Article VI: 3A: The election of all Officers shall be held annually at the next to last Senate meeting of the Spring semester; nominations will be opened at the regular meeting prior to the election.

Practically speaking this means that the voting must take place during the meeting of the senate. In order to expedite the process while allowing candidates time to circulate a statement of their position I suggest the following procedure:

GSS Motion 1-15: Motion to Establish a Temporary Procedure for the Spring 2015 Executive Committee Election

- Nominations will take place at the regular GSS meeting before the elections (3/11).
- A short written statement from each candidate will be due the Wednesday following the meeting of the nominations, sent to the Parliamentarian and then circulated as a one collected document by the Communications Director (3/18).
- The second to last meeting of the GSS will have a discussion section of fifteen minutes, prior to the election, for the senators to ask questions of the candidates directly or forward any questions from their respective constituencies. The discussion section can be extended by ten minutes with a majority vote of the senate (4/1).

The goal of this motion is two-fold, to give the senators a chance to see a statement from the candidates in a form that will allow for private consideration, and it will give senators an opportunity to ask questions to the candidates based on their prepared statements.

Absent from this procedure is a time for the senate to discuss the candidates in their absence. Concerns have been raised that this practice has done more harm than good, resulting in feelings of intimidation, favoritism, and unproductive discussion, rather than fruitful evaluation of the candidates. It is my hope that by circulating statements from the candidates early the senate will be better prepared for the election the following meeting, and the emphasis will be placed on conversing *with* the candidates rather than talking *about* them

Detailed Report

Books

The committee has determined that this initiative should be led by graduate and undergraduate students at the university. The issue with cost of course texts and book buybacks has been broken down into 3 main themes. The following themes are 1) Student Expenses 2) Co-op Benefits 3) Faculty Benefits. The committee was originally tasked to understand more about faculty benefits and their relationship with the Co-Op; however, the committee believes this issue spans across all 3 themes. In order to begin working on these three areas, we will be gathering research and contacting UConn PIRG and other organizations already pushing for textbook change on campus.

Transportation/WRTD Issues

Janet Freniere from Transportation Services discussed issues with graduate student bussing and WRTD. During the meeting, she stated that the Executive Leader, Mindy Perkins, of WRTD was not open to changing nighttime bussing services. Perkins stated that it would interfere with the Foxwoods Casino

nighttime bus schedule, which helps commute individuals in the Welfare to Work program and casino visitors. Moreover, this is an issue because WRTD is also subsidized by the casino.

Freniere also stated that UConn is unable to provide extra buses or transportation for graduate students because they are already short staffed and lacking vehicles for accommodation. They only recently hired more individuals, but they are all still in the process of training during winter break. We discussed supplying our own staff to drive WRTD busses. Originally, it seems that the WRTD buses were driven by UConn staff, but WRTD stated that our drivers were costing them too much money by driving the vehicles.

Along these lines, Freniere mentioned issues with the lack of transparency from WRTD, which she is hoping will change soon. She communicated that Transportation Services has been listening to the voices of the student population, and it pushed for more student friendly changes. However, they have been unable to compromise with WRTD.

The largest update that Freniere provided was that WRTD is becoming part of Connecticut D.O.T. effectively immediately. It is not expected that the Mindy Perkins of WRTD will still be Executive Director after WRTD changes hands. From Freniere's interactions with Connecticut D.O.T., she explained that D.O.T. has been more open about providing services to accommodate the needs of the student population. Currently, there is no resolution. An alternative suggestion was to get another bus or subsidy through the county of Mansfield in the meantime.

WRTD

John Armstrong has suggested a meeting with Bill Wendt, director of transportation. Currently waiting to hear more about setting up meeting times before moving forward.

CAREER SERVICES

Plan to gather contact information to give Kay Gruder. Discussed ideas for easier involvement in student life: checklist of things to do, possible interaction with people in non-academic positions. Plan to ask about progress on these fronts (Kay also has to propose and pass new ideas).

Discussed the need to encourage students to meet with her if they have ideas about what might improve career services for graduate students.

UCONN HEALTH

Discussed possible gaps in health services, such as glasses. Plan to talk with Mike Kurland (director of SHS) about the possibility of eye exams. Plan to gather information about what our current insurance covers regarding eye glasses and put together an information sheet.

COMMUNITY

Discussed the need for a more vibrant graduate life. Plan to have a monthly get-together (e.g., Chuck's, Pub 32), which can be posted on a calendar or emailed out. This would facilitate cross-departmental interactions.

Action Items for Senate

- Feedback on community involvement: is there interest in monthly events?
- Gather department head names and contact information
- Vote on honorarium for tax information session (no guarantee, but plan to reach out and ask if the person from last year would be willing to come again)

Apportionment Report for AY15-17

Adopted by the Graduate Student Senate on

RELEVANT GSS BYLAWS

Bylaw III, Section 2, Part C.iiv

Academic constituencies shall be apportioned at least three-fourths of the total number of seats apportioned, including at-large seats but not including the GSS officers.

Bylaw III, Section 2, Part D

While the Procedures Committee shall have flexibility in apportioning seats in the Senate amongst the academic constituencies, the following guidelines should be used:

- i) Dividing lines between the enrollments required for each level of representation (1, 2, 3, or more seats per constituency) should correspond to natural breaks in the distribution of constituency enrollments.
- ii) Constituencies within roughly the 50th percentile of the distribution of constituency enrollments should receive 1 seat.
- iii) Constituencies within roughly the 50th - 75th percentile of the distribution of constituency enrollments should receive 2 seats.
- iv) Constituencies above roughly the 75th percentile of the distribution of constituency enrollments should receive 3 seats.

Bylaw III, Section 3, Part A

At least one-twentieth of the apportioned seats shall be at-large. All graduate students who do not already represent a constituency in the Senate or serve on the Executive Committee shall be eligible to be at-large Senators.

PERCENTILE DIVISIONS, AY15-17

- **50th percentile** = 59 students. Any academic program having 56 or fewer students is apportioned one Senator according the above Bylaw.
- **50th through 75th percentile** = 60 to 122 students. Any academic program having between 60 and 122 students is apportioned two Senators according the above Bylaw.
- **75th percentile** = 123 students. Any academic program having 123 or more students is apportioned three Senators according the above Bylaw.

DURATION OF THE APPORTIONMENT

While this report is based on data included in the Fall 2014 Graduate School Enrollment Report, the apportioned Senate representation applies to AY15-16 and AY16-17 according to GSS Bylaw III, Section 2, Parts A and B. The apportionment must be redetermined by the first meeting of the Spring semester, 2017.

CHANGES IN REPRESENTATION SINCE LAST APPORTIONMENT

The following constituencies have received a reduction in senators apportioned:

- Communications, from 2 to 1.
- Educational Leadership, from 3 to 2.

The following constituencies have received an increase in senators apportioned:

- Agricultural & Resource Economics, from 1 to 2.
- Chemical & Biomedical Engineering, from 1 to 2.
- Computer Science & Engineering, from 2 to 3.
- Operations & Information Management, from 2 to 3.
- Speech, Hearing, and Language Sciences, from 1 to 2.

The following constituencies have been combined:

- Management and Marketing are now Business Administration.

The following constituencies have been added:

- Clinical and Translational Research

- Digital Media and Design
- Sports Management

The following constituencies are no longer recognized as per Article III, Section I Part A of the Constitution of the Graduate Student Senate:

- Judaic Studies (No current graduate student enrollment)
